# 1. Information we collect

**LSNTAP collects personally identifiable information provided by visitors to LSNTAP's website. We may combine information collected through means such as cookies or third-party analytics tools with other information maintained by LSNTAP. LSNTAP's website uses Google Analytics. It is a free website analytics service offered by Google that gives us insights into how users find and use our website. ## **Information Collected Automatically through Cookies and Similar Technology**

- **Our web server and analytics partners collect information including**
  - **device**

- **operating system**
- **browser**
- **access domain**
- **IP address**
- **pages visited**
- **page that referred you to our site and exit pages**
- **and other system settings**
- **Mobile devices:**
  - **Your Location.** “Precise Location” lets an app find a user’s location using the GPS of the device as well as cell phone towers and Wi-Fi networks.
  - **Hardware-** For example, the “Take Pictures or Video” permission allows an app access to the device’s camera.

**Most browsers give you the option of enabling, restricting, and disabling cookies. If you disable cookies, you will not be able to use all the features of our website or our web services.**

### **3. Information sharing**

**If our business structure changes - If we reorganize or stop serving clients, we may transfer your personal information to a third party only when they agree to protect your personal information according to the terms of this Policy.**

## **4. Information Protection and Security**

**We will not rent or sell your information to third parties.**

**LSNTAP has implemented generally accepted standards of technology and operational security to protect personally identifiable information from loss, misuse, alteration or destruction:**

- **SSH (Secure Shell) protocol. SSH is a software package that enables secure system administration and file transfers over insecure networks. The SSH protocol uses encryption to secure the connection between a client and a server. All user authentication, commands, output, and file transfers are encrypted to protect against attacks in**

**the network.**

- **Two -Factor Authentication (2FA) to protect customer sensitive information.**
- **CryptoAuditor to monitor sessions to the servers, both in real-time as via recorded sessions.**
- **Only authorized LSNTAP personnel are provided access to personally identifiable information and these employees have agreed to maintain the confidentiality of this information.**

## **5. Third party links**

**LSNTAP may link to other websites which do not operate under LSNTAP's privacy practices.**

**When you travel to other websites, LSNTAP's privacy practices no longer apply.**

## **6. Data Retention**

**The information you submit to us will only be kept as long as needed for the reason it was obtained. Mailing list information is kept until a user unsubscribes or users requests that we delete that information.**
