**Kristofer Greig** is a third year law student at Michigan State University College of Law. He has experience with IT and a few programming languages, as well as Linux systems.

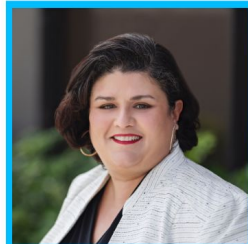
## **Advisory Committee**

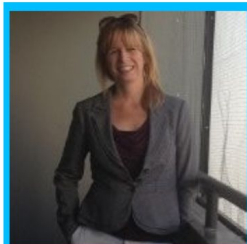

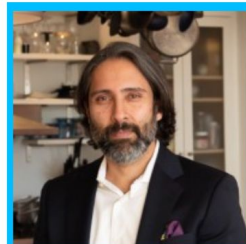

LSNTAP's Vision is: **All legal aid organizations have access to curated information about technology which they use to deliver effective legal services.**

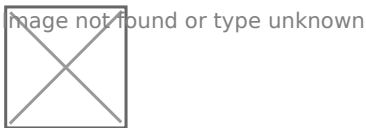
LSNTAP's Values are:
